# GUTHRIE RACING RZR PRO CAR GIUEAWAY

# NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN.

The Guthrie Racing RZR Pro Car Giveaway (the "Sweepstakes") is intended for legal residents of the United States of America ("USA"). It shall be construed and evaluated under all applicable federal, state, and local laws. Void where prohibited.

# 1. SPONSOR

This Sweepstakes is sponsored by Guthrie Racing.

# 2. ELIGIBILITY

Open only to legal residents of the USA, who are at least 18 years of age (or the age of majority in their state of residence). Employees, contractors, and immediate household members of Sponsor, its affiliates, or their promotional agencies are not eligible.

#### A. Purchase Method

- 100 entries per \$1 spent (pre-tax, excluding shipping/handling).
- Example: A \$30 product = 3,000 entries.
- Bonus multipliers may be announced by Sponsor from time to time.

# B. Free Method of Entry – No Purchase Necessary

- Limit: One (1) email submission = one (1) entry for the entire Promotion Period, unless otherwise stated.
- Free entries have the same chance of winning as purchase entries.

All entries must be received by the close of the Promotion Period. Proof of submission does not constitute proof of receipt.

Failure to respond or complete documents may result in disqualification and selection of an alternate.

# 9. RELEASE & LIMITATION OF LIABILITY
